

SMRT Taxis Book and Win Promotion 15 December 2016 to 31 March 2017

Terms and Conditions

The following terms and conditions (and all subsequent revisions or amendments made from time to time by SMRT Taxis Pte Ltd (“**SMRT**”)) shall apply to all the lucky draws conducted and organised by SMRT under the SMRT Taxis Passengers Lucky Draw Promotion (the “**Promotion**”).

The Promotion period will be from 15 December 2016 to 31 March 2017 (the “**Promotion Period**”). Notwithstanding the aforementioned, SMRT reserves the right at its sole discretion, to terminate the Promotion, shorten and/or extend the duration of the Promotion Period and/or amend, modify, delete, replace or revise the terms and conditions of the Promotion, without any prior notification and without incurring any liability to any party whatsoever.

1 Eligibility

- 1.1 Subject to Clauses 1.2 below, all passengers are eligible to participate in the Promotion.
- 1.2 Passengers who have more than 50 bookings for the month of December 2016 and more than 100 bookings per month for the remaining Promotion Period are not eligible to participate in the Promotion.
- 1.3 All eligible passengers who make a booking via any of SMRT’s booking channels and complete the trip will be entered automatically for the Monthly Lucky Draw for such qualifying period.
- 1.4 All eligible passengers will be entitled to enter for the Monthly Lucky Draw for every completed trip made via any of SMRT’s booking channels. Eligible passengers will be entitled to 1 chance per completed trip, from the 1st to 14th booking. From the 15th booking onwards, eligible passengers will be entitled to 2 chances per completed trip.
- 1.5 All eligible passengers who have made bookings via any of SMRT’s booking channels and completed trips, with the highest number of bookings during the period from 15 December 2016 to 31 March 2017, will be entered for the Grand Prize Lucky Draw. The Grand Prize Lucky Draw will be held in April 2017.

2 Lucky Draw and Prizes

- 2.1 The Promotion comprises: -
 - (a) twelve (12) prizes for the Monthly Lucky Draws and
 - (b) one (1) prize for the Grand Prize Lucky Draw

((a) and (b) above collectively referred to as the “**Lucky Draws**”).
- 2.2 The Monthly Lucky Draw will have 12 winners in total and the Grand Prize Lucky Draw will have 1 winner.

2.3 The prizes for the respective Lucky Draws shall be as follows: -

2.4 All Lucky Draws will be conducted at SMRT Taxis Contact Centre (6 Ang Mo Kio Street 62 Singapore 569140).

2.5 The Monthly Lucky Draws will be conducted at 3.00 pm on 06 January, 10 February, 10 March and 07 April 2017 after each respective qualifying period, and the Grand Prize Lucky Draw will be conducted at 3.00pm on 14 April 2017 unless decided otherwise by SMRT in its sole and ultimate discretion.

2.6 For each of the Lucky Draw prizes, SMRT shall have the right to draw reserve winners in the event that the winner is disqualified. SMRT's decision(s) as to the winner(s) of the Lucky Draws shall be final, binding and conclusive. SMRT shall

not in any way be obliged to provide any reasons or entertain any correspondence with respect to its decision(s).

- 2.7 The list of the winners of each Lucky Draw will be placed on the SMRT website.
- 2.8 Winners may also be notified by post or phone at the number provided to SMRT. SMRT shall not be obliged to verify the phone numbers provided to SMRT and shall not be responsible for any failure to contact any of the winners.
- 2.9 Prizes must be claimed within 2 months from the respective Lucky Draw dates at SMRT Taxis Contact Centre (Ang Mo Kio, Blk A, Level 2). All prizes which remain unclaimed 2 months from the respective Lucky Draw dates for any reason whatsoever may be donated to a charity chosen at the sole discretion of SMRT and no claims whatsoever (whether for the prize, payment or compensation) shall be entertained.
- 2.10 All requests for the extension of the validity period of the taxi vouchers shall not be entertained. The taxi vouchers are not replaceable and SMRT will not entertain any claim for any taxi voucher lost, torn, defaced or damaged. The extension is also not applicable for the hotel accommodation, attraction passes and complimentary Vellfire limousine ride.
- 2.11 More than one taxi voucher may be used on the same occasion. However, there shall not be any refund if the cost of purchase is less than the aggregate value of the taxi voucher(s) used.

3. General

- 3.1 SMRT reserves the right to postpone, suspend, cancel or limit the Promotion at its sole discretion, at any time upon the occurrence of any event(s) or circumstances beyond their control which hinder, prevent or affect (or may likely to have such effect) the Promotion (or the fulfillment of the terms thereof) including, without limitation acts of God, natural disasters or catastrophes, riots or wars (whether declared or not), terrorist activities, epidemics, health threats, quarantine requirements or any change or issuance of any applicable laws.
- 3.2 By participating in the Promotion, each passenger agrees to be bound by these terms and conditions or such other rules and regulations as imposed by SMRT. Each passenger shall also be deemed to submit to all decisions of SMRT, which shall be final and binding on all matters relating to the Promotion.
- 3.3 SMRT shall have the right to use pictures and photographs taken in relation to or in connection with or arising from the Promotion and to disclose and publish the name and any other particulars of all or any winners for publicity purposes and each passenger who is a winner shall co-operate and participate fully in the activities organised by SMRT for these purposes, without any payment, fee or compensation whatsoever.
- 3.4 The Promotion shall in all respects, be governed by the laws of Singapore. These terms and conditions are not intended to confer rights on any third party, whether pursuant to the Contracts (Rights of Third Parties) Act (Cap 53B) or otherwise, and no third party shall have any right to enforce any provision of these terms and conditions.
